- Grants Update
  - o Department of Libraries grant for summer reading program
    - Now can use funds to purchase supplies

- Also a projector to show a movie outdoor
- \$200 grant
- o Dollar General Youth Literacy Grant Due in May
  - Americorp mid year report due soon
  - VT Children's Foundation Report is due this week
- Big Rig Day
  - o Planning the event with Highgate Recreation Director
  - o 10 yeses lots of maybes
  - o Looking at doing it at the airport as a drive through
  - o April 10 from 8 12
  - o Signup portal at Highgate Rec website
- Book club and volunteer update
  - o Four volunteers 3 social media volunteers 1 event planning
  - o Wrapped up middle school book club
  - o One wants to continue, so will do another one
  - o High school book club has three signed up
  - o Reading "The Hate You Give"

## **New Business:**

- Seed Library
  - o As part of Lauren's project, supposed to do something with gardens
  - o Old records had information about about doing a seed library
  - o Applied for starter batch, anyone who requests seeds, could get some with their books
  - o Idea people save seeds at the end of the year and donate them back
  - o Maybe look at High Mowing Seeds or Gardener's Supply for donations
- Budget
  - o Bethany shared proposed budget
  - o She and Hadely met to do budget adjustment
  - o July 1, 2020 December 31, 202 actuals shared
  - o VT Children's trust foundation has not arrived yet, anticipation \$14,025
  - o Fundraising and individual donation \$1,100 so far, anticipated \$2,000
  - o Was hoping to achieve \$10,000, but may need 501 C3 before we can apply for some
  - o Will not get \$2,000 storage unit claim
  - o Appears expending more on payroll than anticipated
  - o Also \$4,000 fee to Americorp has not been paid yet
  - o Truck repairs budgeted at \$7,000, closer to \$10,000
  - o Mileage and fuel are down
  - o FY 20 \$2,000 moved over to the credit union
  - o Should have FY21 approved budget to approve for next meeting
  - o Tim suggested breaking out insurance into different categories

- o DUNS Number
  - o Connie at FCIDC just did this, she could help
- Building Bright Futures Book donation
  - o They bought books, Hadely is working on picking some up
  - o They ask we include a BBF flyer when we distribute these books
  - o Will start with childcare providers to distribute these
  - o Books are social emotional books geared towards helping kids cope with the pandemic
  - o Will have 62 books, two or three different titles
- o Other Business
  - o Still one board vacancy
    - Preference would be to have someone from the Islands
    - Tim reaching out to contacts to see if they have any suggestions
